## JOHN L. HILL, JR.



Hill, 83, of Houston, died July 9, 2007. He received his law degree from the University of Texas School of Law and was admitted to the Texas

Bar in 1947. He began his law career with the Houston firm of Helm and Jones, and then was a founding partner in Hill, Brown, Kronzer, and Abraham, where he practiced for approximately 15 years. He served as Texas secretary of state from 1966 to 1968 and as attorney general from 1973 to 1979. After working as an attorney with Hughes and Hill, he was elected chief justice of the Supreme Court of Texas in 1984 and served until 1988. In 1997, Gov. George W. Bush appointed him to the Texas Lottery Commission. Hill was an attorney with Locke Liddell & Sapp, L.L.P. until his retirement in 2005 and a shareholder in Winstead, P.C. from 2005 until his death. Along with family and friends, he established the John L. Hill Trial Advocacy Center at the University of Texas School of Law. Dedicated on April 2, 2004, the center oversees the practical training of UT law students in trial and appellate advocacy. The center houses the John L. Hill Teaching Courtroom, as well as three additional teaching courtrooms named in honor of other distinguished UT Law alumni. Hill served in the U.S. Navy during World War II. He is survived by his wife of 61 years, Elizabeth Graham Hill; son, John Graham Hill of Houston; daughters, Melinda Elizabeth Hill Perrin and Judge Martha Hill Jamison, both of Houston; 10 grandchildren; and four great-grandchildren.

## THOMAS DANIEL MCGOWN



McGown, 95, of Houston, died May 25, 2007. He received his law degree from the University of Texas School of Law and was admitted to the

Texas Bar in 1934. He was a private practitioner from 1934 to 1942. From 1942 to 1981, he was a partner in Vinson & Elkins, L.L.P. He is survived by his wife of 38 years, Elaine Royce McGown; daughters, Rev. Carol McGown Blaine and Susan McGown Boyes; stepsons, Thomas L. Royce, Jr. and Ben L.
